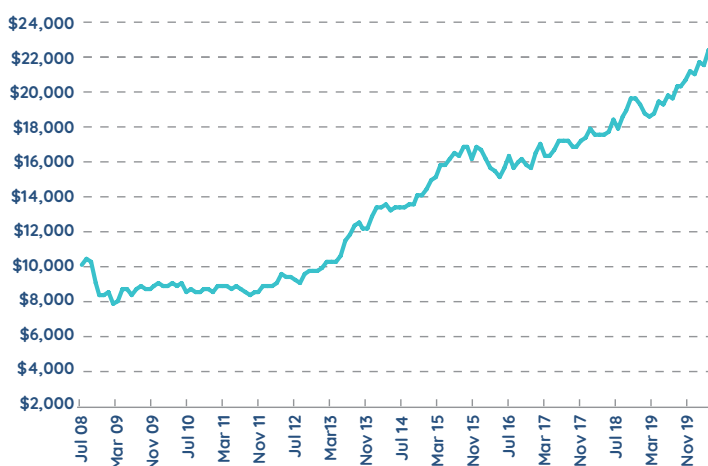

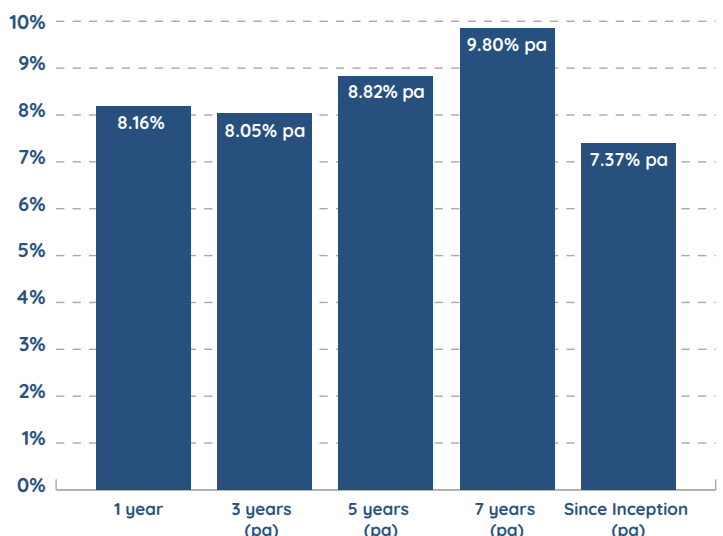

Annual Distributions⁷



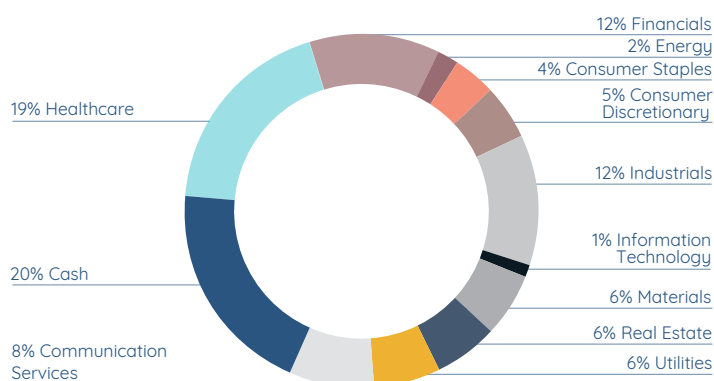

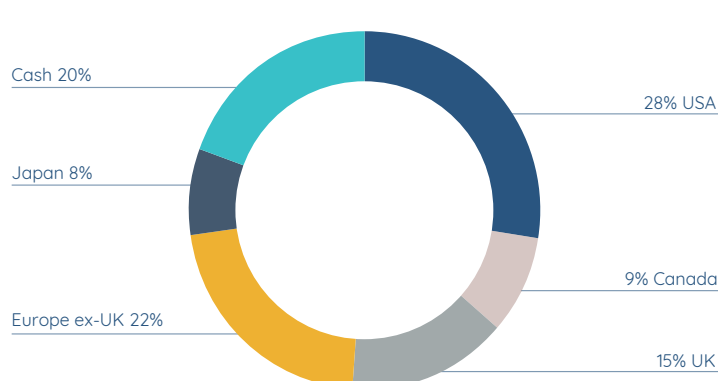
